Tax timing

Most consumers and small business owners file their taxes early, sharing a desire for faster refunds and avoiding penalties. They all find the process grueling and time consuming, analogous to that of medieval torture.



Tax confidence

Even for early filers, the road to tax deadlines is stressful for individuals and small business owners alike. Many aren't confident they're doing it accurately and even fear they could face potential penalties.



Tax challenges

Tax preparation is difficult for consumers and small business owners. Discerning ever-changing tax rules and regulations, and the volume of paperwork are among their top challenges.



Tax tech

Most people use digital tools to support their personal or business tax prep. Despite recognising Al's potential to simplify the filing process, the vast majority of taxpayers are yet to harness it.


How small business owners approach tax time and use technology to help

Time and difficulty are among the top tax struggles for small business owners

Common tax difficulties

- 1. Managing paper documents (51%)
- 2. Organising materials for tax professionals (47%)
- 3. Navigating complex rules and regulations (43%)

Time spent preparing and lodging their tax return:



Approx. 1 in 4 spend
11+ hours on their tax return

Filing taxes early and correctly is a priority for small business owners, driven by cash flow needs, a fear of getting audited and a lack of confidence in getting it right



Typically file their tax return early, keen to get their refunds as quickly as possible



Want to get their tax return right to avoid penalties or audits



Doubt their ability to accurately prepare business taxes

Small business owners' top reasons for not filing early:

- 1. Struggle with time management and balancing other responsibilities (57%)
- 2. Complexity and confusion of preparing taxes (26%)

Small business owners are embracing technology for tax prep, but are yet to leverage AI

72% of small business owners use technology to prepare tax returns, only 11% use AI assistance.




Recognise the potential benefits of AI


For many consumers, filing taxes is a punishing task, taking hours to navigate complex rules and paperwork


Consumers see the potential for AI to make tax time easier, but data concerns are holding them back
